## NEW ZEALAND MOVIE PIRATE SENTENCED TO TWO YEARS IMPRISONMENT

## First Prison Sentence Awarded for Movie Piracy Under Copyright Act

Auckland – On August 25, the Manukau District Court sentenced 42-year-old John Houston to two years imprisonment for illegally copying and distributing pirated copies of movies. Judge David Harvey also ruled that Houston would have to pay the New Zealand Federation Against Copyright Theft (NZFACT) reparations of NZ\$5,000 (US\$3,175). On July 5, Houston pleaded guilty to 21 charges of illegally copying and distributing pirated copies of movies.

Houston was arrested on November 8, 2005 following a raid on his home, during which police, accompanied by NZFACT representatives, discovered 10 optical disc burners connected to a server with a one terabyte (1,024 gigabyte) storage capacity. Four hundred and eighty-six movie "masters" were stored on the server.

Police caught Houston in the act of burning pirate discs and discovered pirated optical discs infringing hundreds of NZFACT member company titles. Records were also found showing and admissions made that Houston had earned between \$120,000 and \$150,000 per year for each of the past five years.

On August 23, Judge Harvey sentenced a music pirate to the first prison term awarded for violations of New Zealand's Copyright Act. The ruling handed down to Houston today is the second prison sentence awarded for violations of the Copyright Act.

"This result today has come after a lengthy and collaborative investigation by NZFACT, the Police and the Department of Internal Affairs. NZFACT is serious about protecting our member companies' Intellectual Property Rights and we welcome the decision given down by Judge Harvey today," said Tony Eaton, Executive Director of NZFACT.

In his August 23 ruling, Judge Harvey said, "It should be made perfectly clear to those who are going to be engaged in commercial copyright infringement that if they are going to embark on this type of activity there will be consequences, that they will be severe, and that if there are going to be downstream consequences for their families then so be it. That this type of activity cannot be allowed to continue and the message must be sent."

## Piracy in Asia-Pacific

In 2005, the MPA's operations in the Asia-Pacific region investigated more than 34,000 cases of piracy and assisted law enforcement officials in conducting more than 10,500 raids. These activities resulted in the seizure of more than 34 million illegal optical discs, 55 factory optical disc production lines and 3,362 optical disc burners, as well as the initiation of more than 8,000 legal actions.
