## MPA AND MUSIC INDUSTRY SIGN ANTI-PIRACY AGREEMENT IN NEW ZEALAND

## Agreement Will Strengthen Education, Anti-Piracy Cooperation

Hong Kong – Today, the New Zealand Federation Against Copyright Theft (NZFACT, representing the Motion Picture Association (MPA) in New Zealand, and the Recording Industry Association of New Zealand (RIANZ) signed a Memorandum of Understanding aimed at increasing the effectiveness of the two organizations' copyright education initiatives and strengthening anti-piracy enforcement efforts.

Mike Ellis, Senior Vice President and Regional Director, Asia-Pacific, MPA said, "The MPA is very pleased to see NZFACT entering into this agreement with RIANZ. We are hopeful that strengthened relations will result in enhanced intellectual property awareness throughout New Zealand, as well as more effective anti-piracy operations. We are in complete agreement that piracy is a scourge that is badly harming creative industries in New Zealand and worldwide."

Kevin Holland, Executive Director of NZFA©T, added, "Our priority is stopping criminal activity. We also want to make sure the public understands what losses are suffered through copyright theft. That's why our alliance with RIANZ is so important."

RIANZ CEO Campbell Smith said, "Our two industries are experiencing similar problems. Our copyrights are being infringed through physical and on-line piracy and we don't intend to stand by and let it continue."

Smith said he believes that the public needs to have an understanding of intellectual property issues and the damage caused when copyrights are infringed. "We intend to focus on education," he said. "When files are illegally shared on the Internet or when CDs or DVDs are ripped and passed on, the creators suffer. The public needs to understand how copyright works."
