NZFACT AND AUCTION SITES WORK TOGETHER TO HELP COMBAT MOVIE PIRACY

Auckland – On March 27, leading New Zealand Internet auction sites *Trade Me* and *Ezytrader* agreed to assist the New Zealand Federation Against Copyright Theft (NZFACT) and the Department of Internal Affairs in the ongoing fight against illegal DVDs being sold online.

This unprecedented agreement in New Zealand has resulted in a modification to the way traders can list DVDs for auction on both sites, forcing them to read and agree to a statement about the authenticity of the material. The statement appears during the process of listing the DVD on the site and before the DVD can be listed, the seller must agree to the statement:

"I certify that the motion picture item I am listing is original and authentic, and I understand that listing a classifiable movie without the New Zealand classification label is illegal and will result in my account being suspended."

Trade Me, New Zealand's largest Internet auction site with over 1.2 million users, sees 620,000 new listings every week, and DVDs account for 10,000 of these listings.

"When we were approached by NZFACT to assist in the fight against movie piracy, we were more than happy to change our format for listing a DVD," said Matt Feisst, Ezytrader Director of Operations.

"The request by Ezytrader and Trade Me of their users to confirm the authenticity of DVDs being sold at auction is a valuable step in improving the online experience for buyers, who can now have greater assurance that their purchases are legitimate and not pirated home video product," said Tony Eaton, Director of Operations for NZFACT, which represents the Motion Picture Association in New Zealand. "In addition, we hope the initiative will provide sellers to reflect on the importance of protecting copyright, which is so important to the country's economic health and which supports so many businesses and individuals."

About NZFACT: The New Zealand Federation Against Copyright Theft was established in 2005 by the Motion Picture Association to protect the film industry in New Zealand from the adverse impact of copyright theft. NZFACT works closely with its members, government and enforcement authorities to protect the New Zealand film and television industry, retailers and movie fans.
